#### **Terms & Conditions**

The following terms and conditions apply to the Atlanta Police Foundation's Relocation Bonus Incentive Program. All terms and conditions must be met in order to be eligible for the relocation bonus funds.

- 1. Applicant must be an active, sworn officer of the Atlanta Police Department.
- 2. Officer must have relocated to the City of Atlanta on or after January 1, 2014.
- 3. Relocation bonus is applicable to both purchases AND rentals.
- 4. Property must be <u>within the six APD patrol zones of the City of Atlanta</u>. If unsure, please visit <a href="http://www.atlantapd.org/findmyzone.aspx">http://www.atlantapd.org/findmyzone.aspx</a>.
- 5. Property must be the applicant's **primary residence** no second homes or investment properties.
- 6. The Atlanta Police Foundation bonus is a **one-time bonus** and is **NOT** applicable to multiple relocations.
- 7. Applicant must provide documentation to demonstrate intent to reside in the City of Atlanta for a period of at least 12 months from the date of application. Relocation bonus does not apply to relocations for periods of less than 12 months.
- 8. Existing lease agreements must have at least 6 months remaining. Applicants with less than 6 months remaining on current lease may be subject to demonstrating lease renewal or extension before relocation bonus will be paid.
- 9. Relocation bonus is payable in <u>one installment for purchases and two installments for rentals.</u> The first installment will be paid upon approval of application. The second installment will be paid six months following initial installment upon verification that applicant still resides in the City of Atlanta.
- 10. <u>Applicant is responsible for applying for the second installment</u>. Subsequent installment dates may vary for area-specific incentives. See attached addendum for details.
- 11. All applications are subject to periodic quality control review by the Atlanta Police Foundation.
- 12. IMPORTANT: Any agreement between the housing provider and an officer for services rendered must conform to the current Standard Operating Procedures of the Atlanta Police Department.

### **Required Documentation**

The following documentation is required in order to process your application for approval:

- 1. Completed application signed by applicant, immediate supervisor, and zone/unit commander (Lt, Capt, Major, or Deputy Chief).
- 2. Copy of Atlanta Police Department identification.
- 3. Completed W-9 form (can be downloaded from the APF Housing website)
  NOTE: Taxes ARE NOT withheld from bonus check. Instead, a 1099-MISC will be issued at the end of the tax year. Please refer to your tax preparer for filing requirements.
- **4.** Documentation of former address (such as former lease agreement, utility bill or other mailing with officer's name and former address)

NOTE: Not required for graduates of classes 211 and later
